INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Municipality of San Rafael, Bulacan, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder contract:

1. Name of Project : Rip-rapping
Contract Location : Sampaloc, San Rafael, Bulacan
Brief Description : Construction of 190 linear meter x .045m thick with 4.5 m depth (including underground) rip-rap for road protection
- Approved Budget for
the Contract (ABC) : P 899,984.80
Source of Funds : General Fund
Contract Duration : 40 calendar days

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R. A. 9184 and its Implementing Rules and Regulations (IRR-A)

The significant times and deadlines of procurement activities are as follows:

1. Receipts of LOI and Eligibility Form from Prospective Bidders	Deadline: December 3, 2007 - 5:00 PM
2. Issuance of Result of Eligibility Check	December 5, 2007 - 1:00 to 5:00 PM
3. Issuance of Bidding Documents	December 6-7, 2007 - 8:00 AM - 5:00 PM
4. Receipts of Bids	Deadline: December 12 2007 - 9:00 AM
6. Opening of Bids	December 13, 2007 - 10:00 AM

Prospective bidders shall submit the Eligibility Requirements to the BAC Secretariat, Second Floor of the Municipal Building, Poblacion, San Rafael, Bulacan. They may also obtain the results of the Eligibility Check by the BAC at the same address.

The BAC will issue bidding Documents only to Bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable fee of P500.00 to the Municipal Treasurer's Office.

The Municipality of San Rafael, Bulacan reserves the right to accept or reject any Bid, and to annul the bidding process and rejects all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder(s).
