Brief Description : Area Preparation including leveling and tampering of garden soil, planting of blue grass and various ornamental plants and provision of decorative boulders.

2. Name of Project : Drainage System & Sidewalk at the New Government Center
Contract Location : Sampaloc, San Rafael, Bulacan
Brief Description : Construction of Drainage System and Sidewalk at the New Government Center.

Source of Fund : PDAF
Contract Duration : 70 calendar days

3. Name of Project : Painting at the New Government Center
Contract Location : Sampaloc, San Rafael, Bulacan
Brief Description : Painting works at the New Government Center main building. Works include preparation of areas to be painted (cleaning, neutralizing, sanding, patching).

Approved Budget for
the Contract (ABC) : P 4,999,996.50
Source of Funds : PDAF
Contract Duration : 90 calendar days

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R. A. 9184 and its Implementing Rules and Regulations (IRR-A)

The BAC will issue bidding Documents only to Bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable fee of xP500.00 to the Municipal Treasurer's Office.

The Municipality of San Rafael, Bulacan reserves the right to accept or reject any Bid, and to annul the bidding process and rejects all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder(s).
